

APPLICATION FOR PASSPORT FOR GREYHOUND FOR REGISTERED PARTICIPANTS Exporting to all countries (except New Zealand)

Under Greyhounds Australasia (GA) rules any person exporting a greyhound(s) to another country must prior to meeting the requirements of the Australian Quarantine and Inspection Service (AQIS) obtain a Greyhound Passport.

All GA Greyhound Passport processing is a Fee Free Service.

Specifically, GAR 44 (1) states that,

(1) Any person bound by these Rules or those of a relevant Registration Controlling Body who is intending to export a greyhound from Australia or New Zealand to any other country must:

- (a) first, obtain a greyhound passport and certified pedigree issued by Greyhounds Australasia; and
- (b) having obtained a greyhound passport, meet the quarantine and inspection service requirements of the country the greyhound is to travel to.

All exporters must apply for the Greyhound Passport directly with GA. This application will be assessed in line with the GA Board approved policy (August 2023) which states:

Where the intended destination for the export of a greyhound is an unregulated country or jurisdiction (including where Greyhounds Australasia has no formal association with a recognised central regulatory authority), a Greyhounds Australasia passport will not be granted.

Exemption of destination requirements for GA Greyhound Passports may be made for greyhounds that have been retired in accordance with the GA Rules and are being exported for the purpose of companion animal/pet.

The Greyhound Passport for a retired greyhound is subject to confirmation that the greyhound is compliant with the GA Rules, in particular:

- GAR 22 Notification of retirement, and
- GAR 24 Mandatory sterilization of greyhounds retired as pets.

A Greyhound Passport will only be issued upon receipt of a completed application form.
